VEET/REES Retrofit Installer Course

This course covers the mandatory training* the Victorian Essential Services Commission's VEET scheme requires you to complete in order to install light globes, shower heads, draft proofing and chimney balloons. It is suitable for the SA REES scheme also.

* ESC VIC requires Installers to also have completed **Work safely at heights** training in order to install light globes, reflectors, draft proofing, chimney balloons (not showerheads and standby controllers). No such requirement exists for installers in SA. Please note GBAT is not currently offering this unit of study.

Course duration:

- Beginners – **2 days**
- Students with experienced who meet Recognition of Prior Learning (RPL) requirements** - **1 day**

** If you do not meet RPL requirements and are NOT an experienced installer, you will need to enrol in a **2-day** course

All training days are 9 am - 4.30pm. **Training Commences at 9am sharp**

- How people use and waste energy and water in their homes and ways to reduce use
- A range of VEET/REES scheme rules and guidelines
- Procedures for working safely as an Installer
- How to install home energy and water saving devices including theory and practical on
 - Compact fluorescent light globes
 - Low flow showerheads
 - Draft proofing
 - Standby powerboards (SPC's)
 - Chimney balloons

Assessment: You will need to complete an assessment involving **written questions** and **practical tasks** in order to pass this course and obtain the Statement of Attainment (certificate) you need to work in the VEET/REES scheme.

- 1) The 1-day course is specially designed for installers who already have some **experience** working in the VEET/REES scheme. You will need to apply for recognition of prior learning (RPL) by providing us with a "**Supervisor/ Third Party Form**" (see website) **signed by your supervisor** confirming your existing skills and knowledge. We will assess your prior learning on registration for enrolment on training day – if you do not have enough prior learning to complete this course, you will need to enrol in the 2-day course at an additional cost – please contact us for details.
- 2) Please advise us prior to commencing the course if you have any **language or learning needs or a disability** that could affect your ability to undertake and complete the course. We will make sure we deliver your training to suit these needs.
